- Students enrolling in the Brockton High School Driver Education classroom must be 15 years 9 months old to register.
- A payment plan is available for the classroom fee which must be paid in full on or before Mod 7.
- Student's achieving honor roll status during the past 12 months will receive a \$50 discount towards a new Driver Education classroom registration. To receive this discount the registration must be done at the Brockton Community Schools office. The report card showing honor roll status must be present at the time of registration for the discount to be applied.
- A class/module will not be counted if a student is tardy more than 15 minutes.
- If a student has missed a class/module, the exact same class/module must be made up in a future class.
- Student must be 16 years old and have a valid learner's permit to register for On the Road Driving.
- Car rental with Driving Instructor is for appointments made at the Brockton Registry of Motor Vehicles only.
- The mandatory parent class is for parents/guardians who have a student in the Brockton High School Driver Education program.
- Students are also expected to complete 40 hours of supervised instruction with parents/guardians.
- A valid student permit must be present when registering for On the Road Driving at the Community Schools office.

The Registry of Motor Vehicles charges a \$15.00 fee to process the classroom and driving requirements of the course. This fee, in the form of a money order made payable to MASS DOT/RMV, will only be collected after the student and parent/guardian have completed all requirements.

\*\*If you did not take the Brockton Community Schools Driver Education classroom, additional fees may apply.
